For your convenience, Northwest Baptist Home Mission can automatically deduct your monthly gifts to our ministry from your savings or checking account. You can save yourself time and money and help us achieve better stewardship of your gifts by saving time and processing costs. No more stamps to lick! No more checks to write! No more checks lost or delayed in the mail. You maintain control of your gift and can change your donation amount or designation just by sending us a written notice. Enrollment in the EFT program takes 4 to 5 weeks, so you may also wish to send your gift with this form. When the process is completed, you will receive a letter confirming that Northwest Baptist Home Mission has enrolled you in this service with the date of your first withdrawal. A record of each withdrawal will appear on your monthly bank statement. If you wish to change or stop your contributions, please let us know in writing. Changes of status to this agreement may take 3 to 6 weeks to be processed.
